Dear Mr. Beukers:

Thank you for your letter of 4 October 1977 concerning the participation of Coast Guard personnel in the Wild Goose Association.

Several months ago, a question arose concerning the participation of Coast Guard personnel in the activities of private, non-governmental societies or associations. The Chief Counsel of the Coast Guard was requested to look into the matter. He found that participation by Coast Guard personnel in the management and control (e.g. as board members) of any private organization or society which is to a lesser or greater extent seeking to affect the course of Coast Guard legislation before the Congress or otherwise attempting to influence Coast Guard policy on any given matter should be discouraged. It was felt that such participation by our members would be inconsistent with their status as Coast Guard employees and could potentially place them in the anomalous position of representing a private group at odds with the official views of the service.

It is my understanding that the Wild Goose Association has, on at least one instance, entered comments during a Coast Guard proposed rule-making process. This would, in my view raise the issue of Coast Guard personnel helping to run an organization which might actively take positions with regard to Coast Guard policy. If this is true, then it would seem to create at least the appearance of a loss of complete independence or impartiality on the part of such personnel.

I can assure you that your Assocation has not been singled out from other organizations. Moreover, there is certainly no objection to our personnel participating as members in your Association, so long as their membership is based upon their particular individual interest in Loran and does not come about solely as a result of their occupancy of a position


or assignment within the Coast Guard. Indeed, it is obvious that membership in the Wild Goose Association could be of benefit to the Coast Guard.

I am certain that their participation as officers of the WGA has not prejudiced their performance of official duties as employees of the U. S. Coast Guard. Our policy decision in no way reflects adversely on any of the three.


THE ROLE OF THE INSTITUTE OF NAVIGATION IN THE PROMOTION OF NAVIGATION METHODS

The Charter of the ION states a primary objective to be "To coordinate the improvements for forward strides made in navigation and related arts and sciences ---". A deficiency in the pursuit of this objective is evidenced by the emergence of a number of organizations over the past few years with the same objective but totally independent of the ION. Substantial duplication of membership exists in these organizations.

Working under the premise that an integrated navigation organization can be more effective in furthering the navigation discipline and in serving a common membership the Council of the ION appointed a committee at the last Council meeting to address the current deficiency and recommend what steps can be taken to consolidate these organizations. To this end, the following plan is submitted for consideration by the governing body and membership of both the Wild Goose Association and the International Omega Association as well as those who feel a satellite navigation, inertial navigation, or stellar navigation organization is required to support their objectives.

The ION has supported, from inception, sections based on geographical areas of coverage and these have been successful in enlarging the membership as well as enhancing the ION structure. Effort is continuing to expand this concept. It is now recommended to institute sections based on navigation methods, for example, Loran Section, Omega Section, et cetera. These sections would have representation in the ION Council similar to that which the existing sections possess.

Each Section elects its own governing committee; formulates its own annual program while coordinating them with other ION activities; and generally conducts business within a federated network. Members are encouraged to participate in various sections as their interest dictates and time permits.
