## Agenda Item 1 - Call to Order

President Uttam called the meeting to order at 9:30 a.m.

# Agenda Item 2 - Minutes of 38th Meeting

Mr. Uttam reviewed the minutes of the previous meeting and called for exceptions and additions. Minutes were reviewed, corrections made and accepted.

## Agenda Item 3 - Reports

- a) Mr. Uttam discussed recent appointments to the board. Mr. Paul Abramson and Mr. Joe Gutman are on the WGA Board of Directors.
- b) Secretary's Report Mr. Abraczinskas reported on the recent election results supplied by the Electrons Committee chairman, Walt Dean.

- 1. Seventeen papers have been selected for presentation. Jim VanEtten has promised R. Warren to look into advisability of a panel discussion.
- 2. Solicitations were sent to industry on 6 August by Bill Rice. He has asked for pledges of \$300 to \$100 depending on company size.
- 3. Press release was sent to CDSI on 12 August. H. Raven is planning to submit 3 more on the speakers and will release approximately 2 weeks apart.
- 4. Budget Estimate is between \$6000 and \$7000 depending upon the hotel furnishing liquor. They charge \$27.50 per bottle and \$2.00 per person for set ups for 2 hours. These figures do not include mailing expense. Income estimate based on \$25.00 banquet charge \$10.00 luncheon charge and \$25.00 registration along with contributions is \$8600.00.
- 5. The hotel will provide 1 complimentary room for each 50 rooms occupied. It is essential for anyone wishing to stay beyond Thursday night to reserve their rooms in advance. Weekends in October are busy and I'm told they will run full. (25 rooms have been reserved todate). Rooms can be reserved direct need to be done 3 weeks in advance.
- 6. Rooms have been designated for each of our functions. The Wednesday night reception will be held on the patio terrace weather permitting.
- 7. I have everything needed for the final mailing except speaker affiliations. I will try to get the program prepared and mailed this month. It is a very tight schedule.
