MINUTES OF THE 42nd BOARD OF DIRECTORS MEETING

The meeting was held in Conference Room 6308, USCG Headquarters, Trans Point Building, Washington, D.C., and convened at 9:30 A.M. The following directors were present:

Agenda Item 1 - Call to order

President Uttam called the meeting to order at 9:30 A.M.

Agenda Item 2 - Minutes of previous meeting

Mr. Andren read the minutes of the previous meeting. Mr. Uttam called for exceptions and additions to them. Minutes were reviewed, corrections made and accepted.

Agenda Item 3 - Reports

a) President's Report -- Mr. Uttam announced that there was an error in the minutes of the 41st Board of Directors Meeting in that Dr. P. D. Ambramson should have been one of the two new board members to serve for the 1979-1980 term. Mr. Uttam also indicated that the cost for the proceedings would be approximately \$3,800. The president reviewed the report of Bill Rice for the 1980 WGA Convention. Mr. Uttam suggested that future WGA Conventions should be planned two years ahead to obtain desired accommodations. The Journal and proceedings were about to go to press.

Bill Rice was present to discuss the accommodations at the Bradford Hotel where the WGA Convention will be held. The following are statistics on the facilities:

- The Meeting Room will accommodate 150 people.

- Hospitality Room approximately 100.

- No charge for the Banquet or Hospitality rooms.

- Parking (free for overnight parking).

- Permission to operate our own bar or hotel will handle the bar.
- Hotel presently being renovated but should be ready by April 1, 1980, for reservations.
- WGA will reserve 125 doubles for the following days:

Subject: Report of committee.

Your committee has attempted to reduce the mailing list by 82 members who have not paid since 1977. In addition there are 105 members who are paid through 1978 and as of the 1st of January are also delinquent. 159 members are now paid up through 1980 and 1981. This leaves approximately 333 members paid up through 1979. A total of 438 members are in arrears on dues.

I have the dues notice ready for mailing and am getting envelopes printed which should be ready by weeks end. I will stuff and seal with a self addressed return envelope and mail as soon as possible. We are having a problem in getting the computer updated properly. On a set of change/deletions which I submitted on 5 November there were 22 omissions out of 82 submitted. On Jan. 25 I submitted 150 changes and many of these were also omitted. It will be necessary to straighten this out before sending the dues notices to prevent an excess of billing paid up members. I do not believe that we need to hold up on the mailing for convention purposes since it only means that our mailing will be larger with the 1977 members still being carried.
