MINUTES OF THE 48th BOARD OF DIRECTORS MEETING

The meeting was held in conference room 8438 of the Nassif Building, 400 Seventh Street, S.W., Washington, D. C. We are grateful to Capt. W. W. Kohl for the conference room. The following Directors were present:

Business of the Board was conducted by consensus. As noted below, certain items of business require a mail poll of the Board in accordance with the By-Laws*. The agenda items are listed in Attachment 1.

Item 1 - Call to Order

President B. Ambroseno called the meeting to order at 0950, 11 March 1981 and made the following announcements:

- (1) Appointments to the Journal Committee have not yet been made. B. Uttam has reluctantly declined to continue as Chairman.
- (2) S. Plusch suggested that the WGA should document why the radio frequency band 90 to 110 KHz should be clear and send copies to authorities currently considering pertinent regulations.
- (3) A special Board meeting will be held on 20 June 1981 in Los Angeles, CA at the Long Beach Port Authority Building in conjunction with a loran seminar at Marina Del Ray to be managed by W. N. Dean, J. F. Culbertson and J. O. Alexander.

(4) The 1981 Convention Chairman has indicated the theme to be, "Loran-C:A High Accuracy System".

Item 2 - Secretary's Report

Secretary L. F. Fehlner indicated that the Minutes of the 46th and 47th Board Meetings had been distributed to all Board Members. In the absence of any corrections, both Minutes were accepted on a motion by C. S. Andren, seconded by V. L. Johnson.

To clarify the record, R. Abraczinskas currently has custody of the WGA files. G. A. Gutman's and P. D. Abramson's terms as appointed Directors have expired. P. D. Abramson is expected to accept reappointment.

J. C. Wall's request for a replacement membership card was relayed to L. D. Higginbotham.

A letter was received from the Internal Revenue Service indicating we enjoy a tax exempt status. (Attachment 2). However, submission of Form 990 is required. (Treasurer action item.)

Item 3 - Treasurer's Report

Treasurer C. S. Andren presented the Treasurer's Report (Attachment 3). He noted that our financial status is about the same as it was one year ago. Theoreport was accepted on a motion by L. Higginbotham, seconded by V. L. Johnson.

Item 4 - Committee Reports

W. N. Dean, Chairman of the Nomination & Election Committee, submitted a written report of nominations for President and for Directors to run for seats to be vacated by C. S. Andren, E. L. McGann, J. P. Van Etten and V. I. Weihe. The slate of nominee's were accepted on a motion by L. D. Higginbotham, seconded by V. L. Johnson. (See Attachment 4.)

Membership Chairman L. D. Higginbotham submitted a written report (Attachment 5).

Constitution Chairman reported that the WGA emblem is officially registered as of 16 December 1980, the culmination of an effort started by the Board four years ago. (See Attachment 6.)

Government Liaison - In the absence of Chairman E. L. McGann, C. S. Andren noted that all objections raised to the UTC proposals for power line communications were rejected out of hand in a large rebuttal document. (See Minutes of 47th Board Meeting). V. I. Weihe noted that a more serious problem is radiation as the result of solid state switching of power. B. Ambroseno will contact the Coast Guard and OTP as to need for more WGA action.

1980 Convention Chairman W. F. Rice submitted a written report (Attachment 7).

Item 5 - 1981 Convention

Chairman W. N. Dean submitted a written report (Attachment 8). Verbal communication from the Committee suggests a super convention due to much west coast interest in Loran-C.

Item 6 - 1982 Convention

After much discussion of possible sites and the policy of previous Boards, it was the consensus that the 1982 convention should be held in the Washington, D. C. area. C. S. Andren moved that the Washington, D. C. shall be the site of the 1982 Convention. L. D. Higginbotham seconded. The motion carried unanimously but will not be binding until ratified by the full Board (see By-Laws).

Item 7 - Mailing and Distribution

Membership Chairman L. D. Higginbotham indicated serious difficulties in maintaining membership records and in making distributions of mail to members using the currently contracted services of CDS, Inc. of Bethesda, MD. C. S. Andren moved that the Chairman of the Membership Committee explore the availability of a more satisfactory means of maintaining membership data than currently provided by CDS, Inc. V. L. Johnson seconded. Motion carried. It was agreed to continue the present CDS, Inc. contract pending the availability of an alternative.

<u>Item 8</u> - Mailing Address

The Board concurred that WGA obtain a P.O. Box in Acton, MA and that this P.O. Box number appear on the letterhead.

Item 9 - Journal Committee

President B. Ambroseno stated emphatically his intent to get the 1980-81 Journal published before the 1981 Convention. To this end, he appointed himself Chairman and L. F. Fehlner Technical Editor. He also appointed J. Weseman to the committee and expects to appoint one more member.

L. D. Higginbotham relayed a message from T. Nolan suggesting the combining of the WGA Journal and the IOA Journal. Board consensus was against such a combination but agreed to invite Omega articles for inclusion in the WGA Journal. Loran-C articles are also to be invited from a broad base of potential contributors.

Item 10 - Proceedings Progress

B. Ambroseno reported lack of progress toward publication due to unavailability of 2 papers, some bibliographies and pictures. The Board recommended that the proceedings go to press immediately with the material on hand including only the titles, authors and abstracts (if available) of the missing papers.

Item 11 - Theme for 1981

The Board discussed briefly alternative themes but finally considered the question moot, noting the convention Chairman's report that "The call for papers is in mailing now."

Item 12 - Other

The Board concurred that, in view of rising costs, the By-Laws should be amended to raise the dues for the first time. Increased costs of mailings and maintaining membership data alone justify an increase in initiation fee to \$15.00 and dues to \$12.00, effective in 1982. A mail poll of the Board is required due to insufficient attendance at the Board meeting and two-thirds favorable is required to amend.

A brief discussion of the status of the Loran-C Signal Specification once more disclosed a rumor that it is just around the corner. B. Ambroseno volunterred to explore the status within the Coast Guard, in particular to determine if a WGA distribution is expected prior to public disclosure.

Item 13 - Adjourn

The 48th meeting of the Board was adjourned at 1310, 11 March 1981 on a motion by L. D. Higginbotham, seconded by V. L. Johnson.



The Ninth Annual Convention of the Wild Goose Association was held in Boston at the Bradford Hotel 22, 23, and 24 October 1980.

The registered attendance this year at the convention was 149. This is a slight increase over last year's registration of 142. Receipts related to the convention were \$14,935.00 with expenses of \$10,481.05 not including the publication and mailing of the Proceedings. With this exclusion, the profit was \$4,453.95. Additional non-convention income from the sale of past proceedings, pins and new memberships totaled \$457.50.

Several comments were received to the effect that it would be more convenient from an accounting and payment point of view if a convention package could be offered. A package that for one price would include registration, banquet and the lunches. I believe that some of the U.S. Coast Guard personnel had a problem with the individual lunch tickets at \$10.00 each.

Hotel rooms occupied were as follows: Tuesday 46, Wednesday, 80 , Thursday 83 , and Friday no data avail.

This year 20 companies generously contributed \$2,600 to the Hospitality Fund (see attached list). In addition, EPSCO invited all WGA Convention Attendees to their outstanding Fish Expo Cocktail Reception Party at the Boston Aquarium. The WGA hospitality operation was open from Tuesday night through Friday noon for lunch, dinner and evening periods. We were fortunate again this year in that the Bradford Hotel let us conduct our own bar operation at no charge (even sold us the liquor at a small mark-up over their cost). A list of liquor used is attached for further reference.

To complete the record, I have also attached a copy of the Convention Notice and Symposium Program. I would also like to express my deep appreciation to those who made the convention a great success:
