Item 1 - Call to Order

The meeting was called to order at 0951 30 April 1987. The number of Directors present met the requirements of a quorum

Item 2- Secretary's Report

The proxy received from Jim Culbertson was presented for the record. (Exhibit 2)

The Secretary's written report which was distributed to all Directors is shown at Exhibit 3.

Since Andren's proxy for the 75th Meeting was the only one meeting the validity requirement, it was pointed out that a quorum did not exist at that meeting. The minutes of the 75th Meeting were then approved with the correction noted.

Item 3- Treasurer's Report

The Treasurer's Report is shown at Exhibit 4. Following a review and discussion of the report, the report was accepted as presented.

A discussion then ensued regarding the use of surplus funds. Andren moved to authorize up to \$600 to stock T-shirts and golf shirts, which display the WGA logo, for resale to members at cost. Illgen seconded. Motion carried. Culbertson has the action.

McGann then moved that 'free' hats bearing the logo be made available to 1987 Convention attendees. Illgen seconded, Motion carried, Toms has the action.

Item 4- Standing Committee Reports

a. Conventions

1986- It was noted that the final account of the 1986 Convention has not yet been received. Dean will contact Marchal for a final report.

1987- Chairman Toms reported that the 1987 Convention will be held at the Crowne Plaza Hotel, Rockville MD, on 20, 21, and 22 October. Tony Pealer will be the Technical Chairman.

1988 – Dean reported for Chairman Bronson that the 1988 Convention will be held in Portland OR in October. Bob Miller will be Technical Chairman.

b. Journal

Chairman Ambroseno requested to be releived as Editor of the Journal. Dean took for action the search for a replacement or for enough help to make it acceptable to Barney to continue as Editor.

The Directors were unanimous in complementing Barney for a superb Journal for 1985/86.

c. Membership

Chairman Toms reported on problems regarding invoices and return addresses. It was agreed that return addresses other than the WGA P. O. Box can be used when appropriate. It was suggested that the Membership Chairman should keep a file of 'master'

copies of all WGA publications.

d. Newsletter

lilgen reported for Chairman Miller that the next Newsletter will be distributed in June. The March issue was delayed due to Miller's involvement in field work. It was noted that the Newsletter should display the Editor's name and address and designate it as the place to send news items.

e. Nominations

Chairman VanEtten presented a slate of candidates for the 1987 Election which contained the name of M. J. Moroney who was at that time not a member of the WGA. Moroney then joined the WGA. Illgen then moved to approve the slate as presented. Ambroseno seconded. Motion carried.

f. Awards

Dean reported for Chairman Frank and requested nominations for the awards.

Item 5 - Special Committees

a. Congressional

Chairman McGann reviewed the ongoing activity regarding tying the loran chains together. He then presented tue following news items:

- 1. Egypt is expected to install a loran chain covering the Gulf of Suez and the northan reaches of the Red Sea.
 - 2. China is expected to be on air by late summer 1987.
- 3. The ONI installed mini-chain in Australia has been opened to the public with great enthusiasm on the part of users.
- 4. Decca coverage in Europe is on a downhill slide and nobody is ready to rely on satellites. Therefore enthusiasm for loran is building. McGann will provide a written report.

Fehlner proposed that a special committee should be formed to monitor and to contribute as necessary to the ongoing loran initiative. Dean asked for volunteers and will appoint such a committee.

Item 6- Old Business

a. Loran and GPS

Scull made a thorough presentation on the DOT and Congressional activity involving moves to improve loran service and to explore the potential of loran and GPS as a hybrid system for sole means aircraft guidance. Schorr indicated that the Coast Guard plans to improve master to master synchronization and will study the loran-GPS hybrid possibilities.

Moroney reported on a aircraft experiment at Venice, LA where a sole means approach plate for loran will be used.

- b. McGann's proposed survey of loran usage was tabled.
- c. Discussion of Culbertson's report on the use of surplus funds was tabled.

Item 7- New Business

Illgen discussed the use of loran in unmanned aircraft and extended invitatioms to attend the afternoon meeting announced in Exhibit 5.

Item 8- Next Meeting

The next meeting will be held in Portland, OR on 14 July 1987 at a place to be announced.

Item 9- Adjournment

The meeting was adjourned on a motion by VanEtten at 1251 30 April 1987.

- 1. Draft briefing charts I have prepared for use by committee members (and other WGA members) for review of Loran-C with DoD officials.
- 2. Plan of action that includes:
