INTERNATIONAL LORAN ASSOCIATION

Minutes of the 120th Meeting of the Board of Directors.

1. Call to Order

The 120th meeting of the Board of Directors was convened on 7 November, 1996 at 1245 PST, at the Catamaran Hotel, San Diego, CA, by President Bill Brogdon.

2. Attendance, Proxies and Statement of Quorum

The following Board members were in attendance:

The secretary reported that the number of Directors present constituted a quorum, but did not equal the two-thirds required for ratification of amendments to the By-Laws.

3. 1997 Convention

Three representatives of Canada attended the first part of the meeting to express their willingness to host the 1997 ILA Convention, in Ottawa, the early part of October. John Butler was the chief spokesman for the group, and he indicated that David Waters, also present, would chair the convention. John Beukers moved, and Dale Johnson seconded, that the offer of the Canadians to host the convention starting on 6 October, 1997 in Ottawa be accepted. It passed unanimously.

4. An Admonition

David Last expressed the view that, since the ILA is an international organization, the U.S. members should be careful in the wording of documents to avoid the appearance of provincialism, referring, for example, to the U.S. Congress, instead of just the Congress. He also pointed out that the Americanization of the pronunciation of foreign names, such as van Willigen, is undiplomatic.

5. Approach by FERNS

Beukers reported that FERNS had approached the ILA suggesting that they become a member. Several possibilities were discussed, including Corporate of Associate membership. No definite conclusions were reached.

6. Newsletter

Brogdon reported that Mike Braasch had agreed to become Editor of the Newsletter.

7. Standing Committees

Johnson advised that some standing committees needed leadership, notably the Nominations and Elections and the Awards committees. Lilley noted that the opcenter can help greatly with the work of the Nominations and Elections committee. The formation of a Finance committee is still a problem.

8. IAION

There was some discussion as to our relationship to the International Association of Institutes of Navigation. Bob Lilley will contact Dave Scull to follow up on the matter.

9. ILA Home Page

Lilley is working on the ILA home page on the internet. Interested contributors should send URLs to Lilley.

10. Moscow 97

We have been invited to participate in Moscow 97. Beukers will be there, and can represent ILA. Others, including Megapulse, may attend. Brogdon will write a letter to Denisov respectfully declining the offer to participate and indicating Beukers' representation.

11. Copies of Correspondence

Lilley requested that the opcenter be copied on all ILA correspondence, and that copies of incoming mail to officers and board members be faxed to the opcenter for recording. Although there was no official motion on this matter, it had the implicit approval of all present.

12. Appointed Directors

Brogdon asked for suggestions for appointed directors. Jim Culbertson, John Butler of Canada, and Peter Kent of FERNS and IALA were mentioned.

13. Stationery

Lilley asked who would need some of the new ILA stationery which would be out shortly with the new Board listed.

14. Contract with Ellen Lilley

It was decided to renew the contract with Ellen Lilley to run the operations center at a rate of \$950 per month. Motion by Beukers seconded by Dean passed unanimously, with one abstention.

15. Spreadsheet on Convention

It was suggested that a copy of the spreadsheet used for the conventions be sent to David Waters to help with the 97 convention.

16. Thanks to Catamaran Hotel

It was suggested that a letter of thanks be sent to the Catamaran Hotel for their cooperation.

Dave,

It is a sad day when this sort of thing happens and it is a reflection on the behavior of some people that should know better. The only conflict of interest is that of the DOT itself. The user community and Congress are of one mind and I thought that in our democracy the people are represented by members of Congress. It is this body that creates the legislation. Unfortunately there are just a handful of people that have their own agendas which in my opinion is tantamount to anarchy. DOT is the taxpayer's servant not master.

I think the situation is going to deteriorate further and it will get really messy unless the DOT does what it is being directed to do. The user community is unanimous, organized and has a lot of bipartisan support on the hill. DOT does not appear to want to listen or even understand. It is not the ILA that is trying to influence the policy it is the users - the ILA happens to be the focal point. The ILA is DOT's communcation point with the users and should use this connection in fullfilling its directive from Congress - not fight it.

One positive thing - you are in good company. It is not the first time this has happened. The Coast Guard had a Commandant 22 years ago that picked a fight with the WGA on policy matters and once again a couple of Directors were "persuaded" to resign. It blew over and for 18 years the cooperation has been great until this latest rhubarb. But this will blow over as well I'm sure. It's just frustrating.

Hope that you will attend the Board meeting as a member in good standing although there was an attempt in the past to get government personnel to resign their memberships! Not exactly democratic.
